### Strategic Procurement Outlook

Updated as at 11 April 2008

The Office of the Commonwealth Director of Public Prosecutions main role is to prosecute offences against Commonwealth law and to confiscate the proceeds of Commonwealth crime. The main cases prosecuted by the DPP involve drug importation and money laundering, offences against Corporation Act, fraud, people smuggling and terrorism.

The DPP adheres to the principles of the Commonwealth Procurement Guidelines and Best Practice Guidance (CPG's) when considering and undertaking procurement. Procurements planned for the DPP are expected to have an approach to the market within the next financial year 2007-2008. The information described below is based on information available at the time of publication of the procurement plan and any updates to this plan will be published throughout the financial year.
