Our Organisation

The Department of Finance and Administration (Finance) provides high quality, strategic policy and financial advice to support government decision-making and improve Australian Government financial management. Finance delivers professional support services to our ministers, parliamentarians and their staff, and the government as a whole. Finance assists the government to achieve its policy objectives by contributing to four outcomes:

Outcome One - Sustainable government finances

Outcome Two - Improved and more efficient government operations

Outcome Three - Efficiently functioning parliament

Outcome Four - Effective and efficient use of information and communication technologies.

Finance adheres to the principles of the Commonwealth Procurement Guidelines (CPGs), through the Chief Executive's Instructions (CEIs) and supporting departmental guidelines, when considering and undertaking procurement.

The Annual Procurement Plan

The APP is designed to draw business' early attention to anticipated planned procurements. The anticipated procurements described in this APP are expected to have an approach to market within the next two financial years (2006-07 and 2007-08) and future years where known. Finance has established arrangements (including exclusive and non-exclusive agreements as well as panel arrangements) for a wide range of property and services. Proposed procurement through these arrangements are not included.

Request documents for all open procurements will be available electronically through AusTender at website: http://www.tenders.gov.au. All planned procurements are subject to revision or cancellation.

The information in this APP is for planning purposes only and is not:

- a pre-solitication;
- an invitation for bid or request for proposal; or
- a commitment by the Government to purchase a described supplies or services.

All of the anticipated approaches have been categorised with a United Nations Standard Products and Services Code® (UNSPSC Code), which will assist potential suppliers, as part of the AusTender Registration process, to subscribe to these business opportunities as they are published on AusTender. The categories are:

- Communications, software, computer equipment, peripherals, components and supplies
- Office equipment, accessories and supplies
- Building, construction and maintenance services
- Industrial cleaning services
- Management, business professionals and administrative services
- Editorial design graphic and fine art services
- Public utilities and public sector related services
- Financial and insurance services
- Healthcare services
- Education and training services
- Organisations and clubs.

Status Description*

The status column included in the APP aims to assist industry in tracking the progress of anticipated procurements.

The description of each status included in the APP is detailed below:

New - A new anticipated approach to the market.

Updated - The anticipated approach date/description/UNSPC code has been revised.

Withdrawn - The anticipated approach to the market has been cancelled. The goods or services are no longer required or will be sourced by an established arrangement.

In Progress - An approach to the market has been released and is being internally processed (stages range from the request for submission to contract negotiations). Complete - An approach to the market that has been completed and a contract awarded.

Blank - The anticipated approach has not changed since the previous APP.
